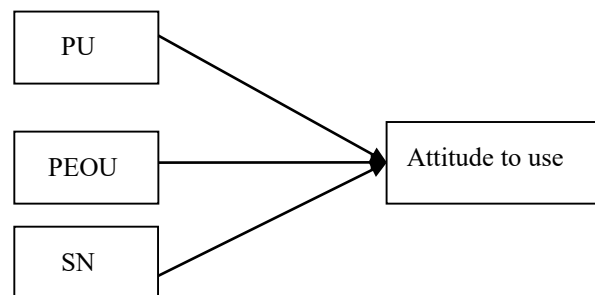


Figure 1 Research model
